

Request for Listing on ODAFF Pesticide Sensitive Location Viewer

With the increase in the number of people growing specialty crops, organic farms and beekeepers in Oklahoma there is a corresponding increased risk that pesticide drift damage will occur. To address these situations the Oklahoma Department of Agriculture, Food and Forestry has established a registry of specialty crops growers, organic farms and beekeepers. We also have information on endangered species, and pesticide restricted areas that pesticide applicators can use to reduce the risk of off target pesticide exposure.

The Registry is voluntary and will be hosted on ODAFF's website. <http://maps.oda.state.ok.us/pslvags/>

For a sensitive crop site to be listed on the Oklahoma Department of Agriculture Food and Forestry sensitive crop registry website, the following criteria must be met:


- The crop is grown for **commercial** purposes and represents a legitimate source of income for the grower.
- The crop - grapes, cotton or tomatoes - is known for its propensity to be economically damaged by herbicides that volatilize readily.
- If it is an organic crop, it must be produced under an organic **certification** program.
- It is one of the following, pecan grove or orchard, peach orchard, watermelon field commercial small fruit or a plant nursery. The grower requests that we publicize the location on ODAFF's website by completing and signing the Registry Form **PICS Form PSLV 04/2011** below.

The locations of sensitive crops and apiaries must be adequately identified. Please provide the longitude/latitude or legal location of the field or apiary. The objective is to give persons using herbicides information they need to avoid damage to your herbicide-sensitive crop or pesticide sensitive apiaries.

To **determine the location of your field**, go to the Pesticide Sensitive Location Viewer at <http://maps.oda.state.ok.us/pslvags/> select the zoom option from the navigation icon and zoom in to the area where your fields are located. Continue to zoom in until you locate the center of the field. The location of the cursor is displayed in the X and Y of Title Bar of the Map.



The Longitude/Latitude (in decimal equivalents) of the cursor in the field is the X (long) and Y (lat) in the Title Bar at top left of page.
